

# VILLAGE OF TELKWA

## ZONING BYLAW NO. 514, 2002

### *A Bylaw to provide for the management of development through a Zoning Bylaw*

**WHEREAS** the Municipal Council of the Village of Telkwa pursuant to Section 903 of the *Local Government Act*, R. S. B. C., 1996 c.323 wishes to adopt a Zoning Bylaw:

**AND WHEREAS** the Council pursuant to Section 906 of the *Local Government Act*, may require owners or occupiers of any building or structure to provide off-street parking and loading spaces including spaces of use by disabled persons for the building or structure;

**AND WHEREAS** the Council pursuant to Section 908 of the *Local Government Act* may require the number, size, type, form, appearance and location of any signs;

**AND WHEREAS** the Council pursuant to Section 909 of the *Local Government Act* may require and regulate the provision of screening or landscaping;

**AND WHEREAS** the Council pursuant to Section 910 of the *Local Government Act* may regulate construction requirements in relation to flood plain area;

**NOW THEREFORE** the Municipal Council of the Village of Telkwa in an open meeting assembled, enacts as follows:

#### **SECTION 1 - ADMINISTRATIVE PROVISIONS**

- 1.1 This bylaw may be cited for all purposes as the Village of Telkwa "Zoning Bylaw No. 514, 2002" and takes effect as of the date of adoption.
- 1.2 If any section, subsection, sentence, clause or phrase in this bylaw if for any reason held to be invalid by a decision of any Court of competent jurisdiction, the decision shall not affect the validity of the remaining portion of the bylaw.

#### **SECTION 2 - ZONING BYLAW**

- 2.1 Schedule A (Zoning Bylaw Text and Map), attached hereto and forming part of this Bylaw, is hereby designated as the Village of Telkwa Zoning Bylaw.
